Agreement (please initial by each)

- _____ I attest that I am not experiencing any symptoms of illness such as a fever, cough, or shortness of breath.
- _____ If I develop these symptoms, I agree that I will cancel my shift before arriving at BEAR...BE A Resource for CPS Kids, as far in advance as possible.

 - _____ I do not believe that I have been exposed to a person with a confirmed or suspected case of COVID-19.
 - _____ I have not been diagnosed with COVID-19 and not yet cleared as noncontagious by state or local public health authorities.
 - _____ I am following recommended guidelines as much as possible - practicing social distancing by participating in group activities of fewer than 10, trying to maintain separation of six feet from others, and otherwise limiting my exposure to the coronavirus.

Assumption of Risk and Waiver of Liability

I, _____ the undersigned, acknowledge that I have voluntarily applied to BEAR...BE A Resource for CPS Kids volunteer program. I understand that the scope of my volunteer relationship with BEAR...BE A Resource for CPS Kids is limited to a volunteer position and that no compensation is expected in return for services provided by me; that BEAR...BE A Resource for CPS Kids will not provide any benefits traditionally associated with employment; and that I am responsible for my own insurance coverage in the event of illness or personal injury as a result of my services to BEAR...BE A Resource for CPS Kids. I understand that my volunteer activities with BEAR...BE A Resource for CPS Kids may include activities that could be hazardous to me, including but not limited to packing, loading, unloading and carrying heavy items, sorting items to be distributed to CPS Caseworkers, transportation to and from work sites, and exposure to people with infectious diseases. I fully understand and appreciate the risks that are inherent to my volunteer activities. I hereby assume the risk of bodily injury, illness, death, medical treatment and property damage resulting from my volunteer as of 3/25/2020 activities, even if resulting from the negligence of BEAR...BE A Resource for CPS Kids or its officers, directors, employees or agents. I hereby release, discharge and agree to indemnify and hold BEAR...BE A Resource for CPS Kids harmless from, and waive on behalf of myself and my heirs and personal representatives and any minors I am responsible for who volunteer with me, any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of BEAR...BE A Resource for CPS Kids, or that may otherwise arise in any way in connection with any voluntary activities with, or for BEAR...BE A Resource for CPS Kids. I understand that this release discharges BEAR...BE A Resource for CPS Kids from any liability or claim that I or my heirs, personal representatives or minors I am responsible for may have against BEAR...BE A Resource for CPS Kids with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from or in connection with my volunteer activities. This liability waiver and release extends to BEAR...BE A Resource for CPS Kids together with all of its officers, directors, affiliates, employees and agents. I agree that this release will be governed by Texas law and that the exclusive venue for any dispute arising from this release will be a court of competent jurisdiction sitting in Houston, TX.
